## Introduction

The following Annual Security Report & Updated Security Policies (ASR & SPU) is published annually before October 1<sup>st</sup> by Kelley Education Inc. Throughout this ASR & SPU, Kelley Education Inc. and its institutions may be referred to as “KEI” and, where applicable, “The institution will refer to the local institution involved in a security matter.

KEI and its institutions prohibit dating violence, domestic violence, sexual assault, harassment, discrimination, and stalking. KEI collects and reports information regarding incidents of dating violence, domestic violence, sexual assault, and stalking that are reported and occur on our Clery Geography or to local law enforcement authorities. To prepare this report, we review any such recorded incidents and request data from local law enforcement authorities. The statistics of these incidents are included within this report.

## Disclaimer

The provisions herein do not constitute a violation of Section 444 of the General Education Provisions Act (20 U.S.C. 1232g), commonly known as the Family Educational Rights and Privacy Act of 1974 (FERPA).

## Definitions

For the purposes of our policies, the following terms shall have the following meanings:

**Awareness Programs-** Policies to provide direct service to those affected by incidents; educate our campus community about violence and prevention; and to address issues of policy and procedure.

**Bystander Intervention-** research on the causes of sexual violence and evaluation of prevention efforts indicates that bystanders (witnesses) can be integral to responding, preventing, and intervening.

**Clery Geography-** the educational campus Geographic Locations under the Clery Act

- On Campus- Any building or property owned or controlled by an institution within the same reasonably contiguous geographic area and used by the institution in direct support of, or in a manner related to, the institution’s educational purposes, including residence halls; and any building or property that is within or reasonably contiguous to paragraph (1) of this definition, that is owned by the institution but controlled by another person, is frequently used by students, and supports institutional purposes (such as a food or other retail vendor).
- On Public Property- All public property, including thoroughfares, streets, sidewalks, and parking facilities, that are within the campus, or immediately adjacent to and accessible from the campus.

**Consent (sexual activity)-** permission through words or actions; understands, and is in agreement to engage in a specific sexual activity. Silence cannot be perceived as consent which is considered “active.”

**Domestic violence-** inflicting physical injury by a household member

**Dating violence-** controlling, abusive, and aggressive behavior whether verbal, emotional, physical, sexual, or a combination of the foregoing in a romantic relationship.

**Discrimination or Harassment-** discrimination or harassment can include racial epithets, slurs and derogatory remarks, stereotypes, jokes, posters or cartoons based on race, national origin, age, disability, marital status, or other legally protected categories.

**Gender Based Harassment-** includes acts of verbal, nonverbal or physical aggression, intimidation, or hostility based on sex or sex-stereotyping are strictly prohibited, even if those acts do not involve conduct of a sexual nature.

**Ongoing Prevention & Awareness Campaigns-** strategies employed over time to reduce risk, raise awareness, and to reduce incidents

**Proceedings-** series of activities following the report of an incident; including, but not limited to an investigation, interviews, and, in certain circumstances, appeals

**Rape-** Penetration, no matter how slight, of the vagina or anus with any body part or object, or oral penetration by a sex organ of another person, without the consent of the victim.

**Result-** The final determination resulting from the proceedings

**Risk Reduction-** tips to limit exposure to incidents

**Stalking-** intentional, repeated following or harassing of another person. It includes a credible threat, either expressed or implied, with the intent to place the person in reasonable fear of death or serious bodily harm.

**Sex discrimination-** unfair treatment in educational opportunity, admissions and employment opportunity against a person because of their sex and/or sexual orientation.

**Sexual harassment-** conduct based upon sex, whether directed towards a person of the opposite or same sex, and may include explicit sexual propositions, sexual innuendo, suggestive comments, sexually oriented “kidding” or “teasing”, practical jokes, jokes about or displays of obscene printed or visual material, questions about sexual fantasies, preferences or history, and physical contact such as patting, pinching, or intentionally brushing against another person’s body.

**Sexual violence/assault-** physical sexual acts against a person’s will or when unable to give consent due to use of drugs, alcohol, impairment, or disability.

## **No Exemptions**

No employee, contract worker, student, vendor, or other person is exempt from the prohibitions in these policies.

## **Jeanne Clery Disclosure**

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act, or Clery Act, mandates that all Title IV institutions, without exception, prepare, publish and distribute an Annual Security & Fire Safety Report.

## Violence Against Women Reauthorization Act

The Violence Against Women Reauthorization Act (VAWA) amended the Jeanne Clery Act to afford additional rights to campus victims of sexual assault, domestic violence, dating violence, and stalking.

## Title IX Sexual Harassment and Sexual Violence Policy

Kelley Education Inc. and its institutions has adopted additional policies to assure strict compliance with; and in accordance with, Title IX of the Education Amendments of 1972 and the Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act (“Clery Act”), along with its amendments made pursuant to the Violence Against Women Reauthorization Act of 2013 (“VAWA”).

Further, Kelley Education Inc. is committed to providing its employees, students, and its guests educational environments free of violence, harassment, and discrimination.

## Policy on Sexual Assault Prevention Programs & Procedures

- **Primary Prevention-** Takes place before sexual violence occurs to prevent initial perpetration or victimization
- **Secondary Prevention-** Immediate responses after sexual violence has occurred to handle the immediate consequences of violent incidents
- **Tertiary Prevention-** Long-term responses after sexual violence has occurred to handle lasting consequences of violence and sex offender treatment interventions.

If you feel you have been the victim of a sexual assault, you have the option to file a confidential or non-confidential report with Title IX Coordinator, and/or to contact the local law enforcement office.

Following a reported incident to the Title IX Coordinator, the Title IX Coordinator will pursue a thorough investigation which may lead to a disciplinary proceeding.

## Title IX Coordinator Role

The role of the Title IX Coordinator is to coordinate compliance; meet with students and employees; resolve complaints; coordinate investigations; assess accommodations; and implement findings.

## **Non-Discrimination**

Kelley Education Inc. does not discriminate upon the basis of race, color, national origin, sex, disability, or age in its educational programs or business activities.

## **Prohibited Conduct**

KEI and its institutions prohibit dating violence, domestic violence, sexual assault, harassment, discrimination, and stalking. Sexual or other unlawful harassment or discrimination includes any verbal, physical, or visual conduct based on sex, race, age, national origin, disability or any other legally protected basis if:

1. Submission to such conduct is made either explicitly or implicitly a term or condition of an individual's education or employment;
2. Submission to or rejection of such conduct by an individual is used as a basis for decisions concerning that individual's education or employment; or
3. It creates a hostile or offensive environment, which means the alleged conduct is sufficiently serious to limit or deny a student's ability to participate or benefit from the student's education program.

## **Campus Policies Regarding Reporting Criminal Offenses**

All students and employees are encouraged to report crimes, suspicious activities, resulting injuries from criminal offenses or other security problems.

Your safety is important. First, notify the appropriate contact at your institution. The appropriate contact will then contact the local police department.

If you experience a life-threatening emergency, please call 9-1-1.

## **Disciplinary Proceedings**

Reported incidents of alleged dating violence, domestic violence, sexual assault, or stalking and involving proceedings will be:

- prompt, fair, and impartial
- conducted in a reasonable, prompt time frame
- conducted by appropriately trained officials who are impartial
- the accuser and accused will have equal opportunities to have others present
- the accuser and accused will have equal access to information used in any hearings
- the accuser and accused will be simultaneously and timely notified of proceedings and results
- the accuser and accused are allowed to appeal

## Sanctions & Remedies

Results from Disciplinary Proceedings may include certain Sanctions & Remedies. Sanctions & Remedies will meet the following criteria.

- Fair and appropriate with the incident
- Consistent with KEI's experience
- Relative to future safety concerns
- Relative to the seriousness of the incident

Sanctions & Remedies may include.

- Reprimand or warning
- Alterations of schedules
- Suspension, Probation, Termination
- Campus restriction (in the case of persons who are neither students or employees)
- Forwarding to law enforcement

## Confidential Inclusion Policy

A victim may elect to not pursue action within the institution or criminal justice system and provide a confidential report. A confidential report may be given to the appropriate contact. The confidential report will help provide the institution with an accurate record of the number of incidents and to allow the community to be made aware. This will allow you to report a crime on a voluntary, confidential basis for inclusion in the crime statistics report.

## Omissions Policy

In certain situations, KEI may remove reports of crimes that have been "unfounded" by law enforcement officials. Any reports removed through this policy will be reported to the Department of Education and the number of such reports will be disclosed in this ASR & USP and will be withheld in the crime statistics report.

## Protective Measures Request

If you report an alleged offense, you may request certain reasonable changes in your academic or work schedule to the Title IX Coordinator.

## Victim's Rights

- Following any alleged offense, whether or not it is reported to local law enforcement, Kelley Education Inc. will work to accommodate victims with schedules upon request, reasonableness, and availability through the Title IX coordinator.
- In response to all complaints, Kelley Education Inc. promises prompt and equitable resolution through a reliable and impartial investigation of complaints, including the opportunity for both parties to present witnesses and any evidence.

- The time necessary to conduct an investigation will vary based on complexity but will generally be completed within sixty (60) days of receipt of the complaint.
- Each institution shall maintain confidentiality for all parties to the extent possible, but absolute confidentiality cannot be guaranteed. In cases where a student or employee does not give consent for an investigation, the Institution will weigh the request for confidentiality against the impact on Institution safety to determine whether an investigation must proceed. Complainants should be aware that in a formal investigation due process generally requires that the identity of the charging party and the substance of the complaint be revealed to the person charged with the alleged harassment.
- The preponderance of the evidence standard will apply to investigations, meaning the Institution will evaluate whether it is more likely than not that the alleged conduct occurred.
- Both parties will receive written notice of the outcome of the complaint.
- During the investigation, the Institution will provide interim measures, as necessary, to protect the safety and well-being of students and/or employees involved.
- If the Institution determines that unlawful harassment or sexual violence has occurred, immediate appropriate corrective action will be taken in accordance with the circumstances involved, and the Institution will take steps to prevent the recurrence of any harassment, violence or discrimination.
- Any employee determined by the Institution to be responsible for unlawful harassment or discrimination will be subject to appropriate disciplinary action, up to and including termination.
- Remedies for student-related claims may include, but are not limited to, an order to stay away, suspension, or expulsion.
- To initiate a criminal investigation, reports of sexual violence should be made to “911” or local law enforcement. The criminal process is separate from the Institution’s disciplinary process.
- To the extent that an employee or contract worker is not satisfied with the Institution’s handling of a harassment or discrimination complaint, he or she may also contact the appropriate state or federal enforcement agency for legal relief.
- The Institution will not retaliate against you for filing a complaint, and will not tolerate retaliation by students or employees. If you believe you have been retaliated against, you should promptly notify the Title IX Coordinator or Deputy Title IX Coordinator.
- Victims of sexual misconduct should be aware that Institution administrators must issue timely warnings for incidents reported to them that pose a substantial threat of bodily harm or danger to other members of the campus community.
- The Institution will make every effort to ensure that a victim’s name and other identifying information is not disclosed, while still providing enough information for community members to make safety decisions in light of the danger.
- The Institution reserves the right to notify parents/guardians of dependent students regarding any health or safety risk, or a change in student status.
- Students and employees can obtain from the Institution’s Executive Director or Human Resources, information regarding existing counseling, health, mental health, victim’s advocacy, legal assistance, and other services available for victims that are available in the community.
- With respect to orders of protection or similar orders issued by a court, the institution will maintain as confidential any accommodations or protective measures provided to the victim, to the extent that maintaining such confidentiality would not impair the ability of the institution to provide the accommodations or protective measures.
- In addition to the Institution, the U.S. Department of Education Office for Civil Rights (“OCR”) investigates complaints of unlawful harassment of students in educational programs or

activities. This agency may serve as a neutral fact finder and will attempt to facilitate the voluntary resolution of disputes with the parties. For more information, visit the OCR website at: <http://www.hhs.gov/ocr/>.

## Appeals

Appeals to investigation findings are to be made in writing within 7 days of the publication of the finding. Appeals will be reviewed and considered for merit if they contain factual evidence that was not included or if an error occurred during the investigation. The appeal process will be completed within 30 days unless additional time is required.

## Retaliation Policy

Students or employees found guilty of participating in retaliation against anyone who reports sexual harassment or impedes an investigation is subject to termination.

Any person who believes they may be a victim of retaliation should immediately report the activity to the Title IX Coordinator.

## Campus Policy for Making Timely Warning Reports

In the event that the Director of Schools determines that a situation constitutes an ongoing or continuing threat, campus-wide “timely warning” will be issued.

## Text & Email Notification Program

All employees and students are encouraged to participate in either our text and email notification program. Text and email alerts are managed by the Director of Schools, Leigh Anne Kelley. Leigh Anne will send out text alerts regarding safety and announcements required by unforeseen circumstances; including, but not limited to school closures from weather.

### Timely Warning

A timely warning is a short description of the crime or incident, time and date, location, reported offense, suspect description, and any other pertinent information pertaining to the crime. This timely warning will also include personal safety information to protect individuals from becoming victims. The timely warning will be distributed via public announcement and may include a memo to a bulletin board. If deemed necessary by the Director, other method of notification may be employed; including, but not limited to, flyers, notices on official school websites and local media.

### Policies Concerning Security of and Access to Campus Facilities

Students, faculty, and staff have access to academic and administrative facilities on campus. The general public may attend certain activities on campus with access limited to only the facilities in which activities are held and within the time that those activities occur.

Professionals engaged in the maintenance of institution facilities will have access to campus facilities. Maintenance professionals will be instructed to which facilities they have access and when they may access the facilities.

Please report any unauthorized person to your campus contact.

### Institution Security Personnel

The authority on each campus is the institutional contact whom students and employees should report criminal offenses. In their absence, the senior instructor should be notified. Senior instructors will notify the Director of any criminal offense. The Director and Ray White have a campus representative role with the local police departments of each institution.

## Prompt & Accurate Reporting

Prompt and accurate reporting to the appropriate contact is an integral component of campus safety. In life threatening situations, please call 9-1-1 immediately.

Our institutions are committed to the principles of self-discipline and self-governance that require that misconduct be reported and the appropriate sanctions be imposed. Each of our students and employees share responsibility in helping us preserve a safe and comfortable learning environment.

First determine if you are experiencing a non-emergency or emergency. Non-emergency is a crime that happened a while ago and there is no direct danger to you or another. If you have just seen or experienced a crime, or a crime is in progress, call 9-1-1.

Remember:

- Your Name, Location (use street address not business name), and your contact number
- Quickly announce the number of people injured and how they were injured for medical response
- Briefly describe what has occurred; how many individuals were involved; and the time and location it occurred
- Note any weapons
- The time and location suspects were last seen and their appearance
- Relevant details (car, smell, sounds, accents)
- Write down any details as soon as possible

If you are the victim of a sexual assault:

- Go to a safe place
- Call 9-1-1
- Do not shower, bathe, or douche
- Do not urinate, if possible
- Do not eat, drink, smoke or brush teeth if oral contact occurred
- Keep the clothes worn during the offense (paper bag is okay but not plastic)
- Get prompt medical attention
- Do not destroy any physical evidence
- Write down all details as soon as possible

## Counselors

Our institutions do not have any trained pastoral or professional counselors.

## Be Safe!

- Be Aware! Recognize your vulnerability
- Report suspicious individuals
- Use buddy system at night or if something “does not feel right”
- Write your name on your belongings
- Use lockers with locks
- If you someone being victimized, let an employee know immediately

- Do not accept rides from strangers

## Drugs & Alcohol

Our institutions enforce drug and alcohol regulations as required in the Drug Free Schools and Communities Act of 1988 and amendments of 1989. The unlawful possession, use, or distribution of alcohol by employees on school property, or as part of any institution activity is prohibited.

Students believed to be using alcohol or drugs may be referred to substance abuse programs outside the institution.

Illegal drugs and drug paraphernalia are prohibited. The possession, sale, manufacture, or distribution of any controlled substance is illegal under both state and federal laws. Therefore, any employee or student engaging in such illegal action will be subject to disciplinary procedures, which could result in sanctions, including termination of employment, suspension or expulsion from school, and criminal prosecution. In addition, the use and/or possession of weapons of any type, including facsimiles, except those in possession of a bona fide law enforcement agency, are not permitted on campus.

## Missing Student Notification

Our schools do not provide on-campus housing; therefore, in accordance with Department of Education and HEOA Sec. 488(g) amended HEA Sec.485 (20 U.S.C. 1092): added HEA Sec.485 (j), we do not have a Missing Person Notification Policy.
